## Assignment of Competitively-Bid Developer Contracts

On MOTION by Mr. Curtis and seconded by Mr. Simpson, with all in favor, the assignment of the competitively-bid Developer contracts, one for mass grading of 85% of the site and the other for Phase 1 and a portion of Phase 2 infrastructure, and authorizing Staff to prepare the necessary documents, were approved.
