# THIRD ORDER OF BUSINESS

Consideration of Resolution 2023-07, Approving a Proposed Budget for Fiscal Year 2023/2024 and Setting a Public Hearing Thereon Pursuant to Florida Law; Addressing Transmittal, Posting and Publication Requirements; Addressing Severability; and Providing for an Effective Date

Discussion ensued regarding the public hearing date and time, Board transitions and a Fiscal Year 2024 meeting location once residential and commercial projects are completed. Mr. Torres presented Resolution 2023-07. He reviewed the proposed Fiscal Year 2024 budget, compared to the Fiscal Year 2023 budget, and explained the reasons for any changes. This is a Landowner-funded budget.

Discussion ensued regarding adding approximately \$230,000 for line item "Field operations" expenses.

The following change was made to the Fiscal Year 2024 budget:

Page 1, "Field operations": Budget approximately \$230,000 spread across the line items.

Staff will coordinate with Mr. Curtis to fine-tune the budget line items for services required in Fiscal Year 2024.

#### TWISTED OAKS POINTE CDD

Regarding the time period for the Boundary Amendment, Mr. Earlywine believes the petition was submitted and it will likely take three months to complete the process; the City of Wildwood will review it and then set it for a first and second reading. Mr. Curtis noted that there is a closing on May 26, 2023 on a part that is being annexed into the boundaries and asked if a new authorization will be necessary. Mr. Earlywine stated if it is already submitted, it is not a big deal but a new authorization will be necessary.

Discussion ensued regarding the anticipated May closing, Boundary Amendment timing, start of construction, when bond funds are needed, status of the construction permits, etc.

Mr. Earlywine will confer with Ms. Buchanan about the boundary amendment and expediting the bond funds.

Mr. Curtis anticipated that the final plat for Phase 1 will be recorded in late-July or early-August and the first closing will be in October.
