FIRST ORDER OF BUSINESS

Call to Order/Roll Call

Mr. Torres called the meeting to order at 11:33 a.m. Supervisors Smith, Curtis and Simpson were present. Supervisors Meath and Lybbert were not present.

Mr. Torres presented Resolution 2023-08 and reviewed the proposed Fiscal Year 2024 budget, which is Landowner-funded.

Mr. Torres presented the Fiscal Year 2023/2024 Budget Funding Agreement between the CDD and LK Twisted Oaks LLC.

On MOTION by Mr. Curtis and seconded by Mr. Simpson, with all in favor, the Fiscal Year 2023/2024 Budget Funding Agreement, was approved.

EIGHTH ORDER OF BUSINESS

Presentation of Restated Master Engineer's Report

Mr. Earlywine stated the Restated Master Engineer's Report is essentially the same as the version previously presented, except that a northern section with 394 units has been added, bringing the total costs to \$69,820,000. The Report has the same findings and conclusions that the Board relies on to levy assessments; namely, that the project benefits the properties within the boundaries of the CDD, that it is feasible to construct and that the permits are expected to be in order.

Mr. Earlywine recommended Board approval in substantial form.

On MOTION by Mr. Curtis and seconded by Mr. Simpson, with all in favor, the Restated Master Engineer's Report, in substantial form, was approved.

Mr. Torres presented the Amended and Restated Master Special Assessment Methodology Report and reiterated the adjustments that Mr. Earlywine mentioned regarding the restated Master's Engineer's Report.

On MOTION by Mr. Curtis and seconded by Mr. Simpson, with all in favor, the Amended and Restated Master Special Assessment Methodology Report, in substantial form, was approved.

Presentation of Second Supplemental Engineer's Report, dated August 2023

Mr. Earlywine presented the Second Supplemental Engineer's Report dated August 2023. The Report is similar to the First Supplemental Report presented for the first bond series, except that this is for Highfield Area 1, Phases 1 & 2, which includes 265 units, costs approximately \$15 million; it has the same findings as the prior Report. He recommended approval, in substantial form, for purposes of the bond issuance.

Mr. Morris arrived at the meeting.
