#### FIRST ORDER OF BUSINESS

#### Call to Order/Roll Call

Mr. Torres called the meeting to order at 10:40 a.m.

Supervisors Curtis, Beliveau and Williams were present. Supervisors Bain and Simpson were not present.

## THIRD ORDER OF BUSINESS

Consideration of Resolution 2024-02, Directing the Chairman and District Staff to Request the Passage of an Ordinance by the City Commission for the City of Wildwood, Florida, Amending the District's Boundaries, and Authorizing Such Other Actions as are Necessary in Furtherance of that Process; and Providing an Effective Date

Mr. Torres presented Resolution 2024-02 and read the title.

Mr. Earlywine stated that there is a currently a multi-family buyer and there might be a slight overlap between the multi-family parcel and a CDD tract that is encumbering the property in question. If that exists, a boundary amendment is needed to remove it; a surveyor is in the process of confirming that.

On MOTION by Mr. Beliveau and seconded by Mr. Williams, with all in favor, Resolution 2024-02, Directing the Chairman and District Staff to Request the Passage of an Ordinance by the City Commission for the City of Wildwood, Florida, Amending the District's Boundaries, and Authorizing Such Other Actions as are Necessary in Furtherance of that Process; and Providing an Effective Date, was adopted

Mr. Torres presented the CDD Drainage Easement Agreement.

Mr. Earlywine stated the Agreement allows the owners to flow their stormwater into the CDD's system. The Agreements that need to be approved are the main Cost Share Agreement, subject to Mr. Curtis reviewing a piece involving the C1 Tract and the CDD Drainage Easement Agreement, which is a blanket easement that covers all the multi-family parcels except for the C1 Tract.

On MOTION by Mr. Curtis and seconded by Mr. Williams, with all in favor, the Primus Drainage Easement Agreement, in substantial form, was approved.

On MOTION by Mr. Williams and seconded by Mr. Beliveau, with all in favor, the CDD Drainage Easement Agreement, in substantial form, was approved.

#### **Consideration of Cost Share Agreement**

Mr. Earlywine presented the Cost Share Agreement, wherein all the multi-family and commercial buyers pay their share, including the Primus tract, subject to modification of their obligation.

Discussion ensued regarding enforceability, a contractual lien, foreclosure, etc.

Mr. Earlywine will include a contractual lien in the Agreement.

On MOTION by Mr. Williams and seconded by Mr. Curtis, with all in favor, the Cost Share Agreement, in substantial form, was approved.
